Policy governing the processing of personal data

(Article 13 of Regulation EU 679/2016)

This is to inform you that the personal data you will provide as a participant in the Study known as "Survey on the mother and baby services in the Province of Trento" will be processed in accordance with Regulation EU 2016/679 (hereinafter referred to as the "GDPR"), Legislative Decree 196/2003, as amended by Legislative Decree 101/2018 (hereinafter referred to as the "*Privacy Code*"), and any other binding provisions (e.g. laws, legislative decrees, regulations, etc.), including the provisions of the WP29, of the European Data Protection Board ("EDPB") and the Data Protection Supervisory Authority as applicable from time to time, and in accordance with the following policy.

Joint Data Controllers

The Joint Data Controllers are the Azienda Provinciale per i Servizi Sanitari [Provincial Authority for Health Services](hereinafter referred to as the APSS), having its registered office in via A. de Gasperi, n. 79 - 38123 Trento, and the Scuola Universitaria Superiore Sant'Anna [Sant'Anna Higher University School] (hereinafter referred to as the SSSA), having its registered office in Piazza Martiri della Libertà, 33 56127 Pisa (hereinafter collectively referred to as the "Joint Data Controllers").

An internal joint data control agreement has been entered into between the Joint Data Controllers setting out their respective responsibilities with regard to compliance with the obligations arising from the General Data Protection Regulation in accordance with Article 26 thereof.

Purpose of processing

Your personal data will be processed by the APSS and SSSA for scientific and statistical research purposes.

Legal basis of processing

The processing of your personal data by the Data Controllers for the above purposes requires your explicit consent, in accordance with Article 6(1)(a) and Article 9(2)(a) of the GDPR. Failure to provide your consent to the processing of your personal data will not prevent you from accessing treatment but will only make it impossible for you to participate in the Project.

Categories of type of personal data processed

The achievement of the purposes of this Project requires the collection and processing of common personal data (for example, email address, mobile phone number) as well as health-related data falling within the special categories of personal data under Article 9 of Regulation (EU) 2016/679.

Data processing methods

The data collected are processed, for the aforesaid purposes, with the aid of such suitable computer and paper-based means as to ensure the security and confidentiality of the data. All data processing operations will be based on the principles of fairness, lawfulness and transparency as laid down by Legislative Decree 196/2003 and Regulation (EU) 2016/679.

In particular, the Survey will begin when you first contact the APSS midwife or gynaecologist. On that occasion, mothers-to-be will be asked to provide an email address and a mobile phone number. This will enable the survey participants to be contacted periodically in order to complete short online questionnaires. The questionnaires are about the experience of pregnancy, childbirth, breastfeeding, child care in the first year of life and the perception of

the child's health conditions. Upon completion of the questionnaire, each participant will receive an email containing information on the mother and baby services, services and some important reminders intended to protect and promote her health and that of her own child.

In particular, the data included in the questionnaires of the Survey on the mother and baby services are collected in a database hosted on a server of the Management and Health Laboratory of the Scuola Sant'Anna di Pisa, which coordinates the Survey, located in Pisa (Italy). The data are processed through electronic means using a special software that allows personal data to be unrelated to the answers provided in the Survey. Specific security measures are in place to prevent data loss, illegal or inappropriate use and unauthorised access, including the use of a secure protocol for transmission from the APSS to the Management and Health Laboratory of the Scuola Sant'Anna di Pisa.

All personal data will be processed by using data encryption and pseudonymisation techniques in order to evaluate the mother and baby services as part of the project promoted by the Autonomous Province of Trento. The results of the Survey will be disclosed and returned to the APSS and the Autonomous Province of Trento in an anonymous or aggregate form.

No automated decision-making processes within the meaning of Article 22 of the GDPR will be used.

Data retention time

Your personal data collected, including through the completion of questionnaires, will be kept for the time strictly necessary for the Project and immediately thereafter they will be destroyed or used anonymously for research purposes by the School.

Nature of data provision and consequences of failure to provide the data

Providing your personal data for the aforesaid purposes is voluntary. Failure to provide your data will make it impossible for you to participate in the Project but will not affect the delivery of health services.

Recipients of the data

Personal data are processed — exclusively for the purposes as mentioned above — by authorised personnel of the APSS, who will act as "Data processing agent/Person authorised for data processing purposes", and by trained and specifically authorised researchers of the MeS (Management and Health Laboratory) of the Scuola Sant'Anna di Pisa. Your personal data will not be transferred to non-EU countries.

The results of the Project may be disclosed through the publication of statistical results, but only in an aggregate form or at any rate in such a manner as to make it impossible to identify the data subjects, including through indirect identifiable information.

Your personal data relating to your health conditions will in no way be subject to disclosure.

Data subject rights

In your capacity as data subject, you have the right to ask the Joint Data Controllers at any time to exercise your rights under Article 15 et seq. of the GDPR. Notably, you have the right to:

- obtain confirmation of whether your personal data exist;
- obtain information about the purposes of processing, the categories of personal data, the recipients or groups
 of recipients to whom the personal data have been or will be disclosed and, where possible, the retention
 period;
- obtain the rectification and erasure of your personal data;
- obtain limitation of processing;
- object to the processing of your personal data at any time.

Data subjects will also have the right to withdraw their consent at any time without affecting the lawfulness of the processing based on the consent given prior to any such withdrawal.

If a data subject decides to withdraw from the Project, his/her data will be deleted and, therefore, will no longer be used for the purposes of the Survey.
